RULES & REGULATIONS

Season 2016 – 2017

1. ORGANISATION AND ADMINISTRATION

- a. The decisions of the Junior League Secretary (JLS), in respect of these rules and regulations and on any other matter related to the GCNA Junior league (GJL), which is not provided for below, shall be considered final and binding on all parties (subject to the right of appeal which is specifically provided for under England Netball's Disciplinary Regulations).
- b. These rules and regulations shall be subject and secondary to the application of England Netball's rules and regulations.
- c. It is the responsibility of all Team Managers, Coaches and Captains to ensure that all players are conversant with the following rules and regulations.
- d. Matches must be played according to INF rules, except where specifically stated in these rules.

b. PLAYING QUALIFICATIONS AND ELIGIBILITY

- a. Application for entry to the GJL shall be open to any club, which is affiliated to England Netball through GCNA.
- b. GCNA will charge an entry fee to the GJL. In addition clubs will be liable for court and umpiring costs as set out in the entry particulars.
- c. In order to qualify to participate in the GJL, clubs shall either be accredited under England Netball's CAPS scheme, or registered at the commencement of the season in which they enter the league and working towards their CAPS. Clubs must have achieved their CAPS accreditation within 18 months of the registration.
- d. Clubs entering in the GJL agree that they will abide by these rules and regulations and will fulfil the costs and commitments of participation.
- e. All players must be Registered Participants of England Netball through affiliation to a club.
- f. All players must have their membership lodged with the England Netball Head Office, and their subscription paid, prior to playing in the GJL.
- g. To participate in the different age banded sections of the GJL, all players must be
 - over 11 but under 12 on 31 August in the U12 section GJL (school year 7),
 - over 12 but under 13 on 31 August in the U13 section (school year 8)
 - over 13 and under 14 on 31 August in the U14 section (school year 9)
 - over 14 but under 16 at midnight on 31 August to participate in the U 16 section (school years 10 & 11).

No player can play out of her age band unless they have complied with England Netball Age Banding Guidelines and completed the form which must be taken to the junior league matches. The form and guidelines are available on the EN web site <http://www.Englandnetball.co.uk/competitions>
Exceptions are - in the case of U13 players, who may play in an U14 squad. Mixed teams of U12s and U13s may play in the U13 section and an U12 player may play up into a U13 squad as a reserve on the day.

c. REGISTRATION OF SQUAD MEMBERS

- a. Squad/results sheets for each participating U14 and U16 team shall be completed fully and presented to the umpires prior to each U14 and U16 league match.
- b. Squad lists for each participating U12 and U13 team shall be submitted to the organising officials prior to the start of each U12 and U13 league competition date.
- c. Once a player has been named on a squad sheet and has played she cannot transfer to another club during the course of the current playing season. Consent to a transfer may be given by the Junior League Secretary in unusual or exceptional circumstances where written request is made by the player and both clubs involved.
- d. Each club may declare up to **12 players** prior to the start of each **fixture date** by completing a results/squad sheet.
- e. Where **2 or more teams** are entered from the same club in any age band, each squad shall **name 4 players** who cannot play down, but can play in higher squads. The names of these 4 players, including those playing in Regional Junior leagues shall be sent to the JLS prior to the start of the 1st match of the season.
- f. Unnamed players can play down one squad. Unnamed players may play in a higher squad, but after playing 8 quarters¹ in the higher squad must remain in that squad.
- g. Squads can be renamed after Christmas.
- h. Where **2 or more teams** are entered from the same club in an age band, these teams must be declared in **order of merit** i.e. A, B, C etc, or in the case of team names these shall be in alphabetical order.
- i. No player can play for more than one team on any given fixture date e.g. if an A & a B team are entered in the U14s league then they cannot play for both teams on the same date.

d. STRUCTURE OF THE LEAGUE

- a. The GJL will consist of as many clubs/teams/age bands as determined by the Junior League Secretary. Each team will play each other once or twice in the relevant age band depending on the number of teams entered.
- b. Tournaments will usually be held for all age groups.
- c. Players entered in the tournaments are to remain in their nominated squads, as results from the tournaments may be required to determine which teams play in the Regional competitions.
- d. In both the U14 and U16 age group, there will be a County Cup/seeding tournament prior to the start of the season to determine divisions for the league in each age group if necessary, and also to determine the 2 top teams who shall enter the Netball South West Regional League.
- e. A player who plays in the U14 and U16 Regional League is allowed to play in GJL, providing they have not played more than 16 quarters at Regional level.
- f. Two squads from the same club cannot be entered into the Regional Competitions unless there are exceptional circumstances. The final decision will be made by the GCNA executive through the Junior League Secretary, after receiving written evidence.

¹ Quarters for U14/U16 teams; halves for U12/U14 teams

- g. Teams will be awarded points as follows: 5 points for a win, 3 points for a draw, 2 points for a losing team scoring within 5 goals of the winner's score (U14 and U16 matches only), 1 bonus point for a losing team scoring more than half of the winner's score, 0 points for a loss. Teams will be deducted 3 points for conceded matches or rule infringements. If two teams have equal points goal average/goal difference/ most goals scored will be applied to determine the correct league position.

e. FIXTURE ARRANGEMENTS

- a. All fixture dates are set at the beginning of the season and matches must be played at the set time and date.
- b. The matches are to be played indoors at a suitable venue which will be booked by the Junior League Secretary for pre-arranged dates and times.
- c. If a team concedes a match, 3 penalty points will be deducted from the team's points. The non-offending team will be awarded 5 points. The **total** court fees for the fixtures must be fulfilled by the club conceding.
- d. If a club has to concede a match this must be the match of their lowest team in that age group.
- e. The Junior League Secretary will be responsible for producing the fixtures for the League.
- f. If a team withdraws from any fixture or tournament then reasonable notice must be given to the organiser otherwise fees will be incurred (reasonable would mean at least 7 days notice in order for the fixtures to be re-organised and clubs informed).

f. MATCH REGULATIONS

- a. All games shall be played to the current INF Official Rules of Netball, except as detailed below.
- b. U16 and U14 matches will consist of 4 quarters of 10 minutes, with intervals of 1 minute at quarter time and 3 minutes at half time. Note: set times have been allocated as per the fixture sheet and matches must be completed within these set time frames to avoid impacting on other matches. If a match does not start on time then the quarters must be reduced so that the following match can start on time.
- c. Umpires shall be responsible for checking players with regard to nails, jewellery etc. as well as the timing of the quarters.
- d. U13 and U12 matches will normally be 10 minutes each way, 1 minute half time and 3 minutes between matches. All teams will play each other once or twice depending on number of entries into the league.
- e. The Junior League Secretary will advise clubs if the length of matches are changed due to circumstances e.g. number of teams, court availability etc.
- f. In the event of injury in the U14 and U16 fixtures, the normal England Netball rules shall apply. There shall be no injury time in other age groups so that an injured player must leave the court for attention as soon as possible and be substituted or return to her position when fit. However, play shall be stopped by the umpires in the case of a serious injury (head, neck or back).

g. MATCH/TEAM OFFICIALS

- a. The organisers will supply and allocate umpires wherever possible. In the event that this is not possible each team must provide a qualified umpire. Teams shall be responsible for payment of umpires' expenses.

- b. The umpire requirements are:
- U16 matches - C award umpire or higher
 - U14 matches – Beginner or above
 - U12/U13 matches – Youth Umpire award or higher
- c. U14 and U16 teams are also required to provide a competent scorer for each match, who shall sit together in a place designated by the umpires. A score flip-chart may also be used to display the scores.
- d. U14 and U16 matches shall be timed by the scorers, or a separate timekeeper if available. U12 and U13 matches shall be centrally timed by the organising officials.
- e. Umpires and captains or coaches are required to sign the scorecard to verify the final score.
- f. Each team must be accompanied by a responsible adult (over 18 years old) at all times and carry a first aid kit.

g. REGISTRATION OF RESULTS

- a. Umpires and captains or coaches are required to sign both Results/Squad sheets to verify the final score for U14 and U16 matches.
- b. For U14 and U16 matches - an official result/squad sheet shall be completed by each team and signed by the captains and umpires and emailed to the Junior League Secretary within 3 days of the match date. For U12 and U13 matches the organising officials shall collate the umpires' results cards.
- c. It is the responsibility of U14 and U16 teams to submit their match results on the GCNA web site (www.glos-netball.org.uk). The Junior League Secretary shall submit the results for the U12 and U13 competitions.
- d. League tables shall automatically be displayed on the web site for each age group.

h. QUERIES, COMPLAINTS & APPEALS

- a. Any team official who intends to raise a query or complaint regarding the playing of a match and/or its result must inform the nominated league official, the opposing team and the umpires on the day of the match.
- b. Any queries or complaints regarding the playing of a match and/or its result must be submitted in writing to the Junior League Secretary within two (2) working days.
- c. All queries, complaints and disputes regarding the playing of a match and/or its result will be determined in the first instance by a sub-committee convened by the Junior League Secretary, which will use best endeavours to determine the issue within ten (10) days of the fixture.
- d. The Junior League Secretary will have the power to determine the penalty to be imposed on teams and players who are in breach of these rules and regulations regarding the playing of matches in the GJL. Such penalties will include reprimands, the deduction of league points, fines, suspensions, and expulsion from the competition, except as specified below:
- The use of an unaffiliated player/umpire will result in a deduction of 3 league points
 - The use of an umpire who is not registered on the GCNA Active Umpire List will result in a deduction of 3 league points.

- The use of an unregistered player or a player, who is under age for the age group (without permission), will result in a deduction of 2 league points
- Failure to play on more than one fixture date may result in expulsion from the League. If a team cancels, the offending team will meet any costs incurred by the non-offending club.

i. MISCELLANEOUS PROVISOS

- a. All clubs will be held responsible for their players, officials and spectators.
- b. It is the responsibility of each club to provide adequate first aid cover for its players and officials, which shall also be made available to the match officials on request.
- c. All jewellery must be removed when playing netball, and players wearing jewellery (including body piercing) will not be allowed on court.
- d. No adornment that may endanger player safety shall be worn. If scarves need to be worn because of religious practices, the player and the coach must ensure that the material used for the head covering is soft, without embellishments which might constitute a danger, and with potential flowing/flapping edges held securely around the neck or tucked into the shirt collar as neatly and securely as possible. No other form of headwear may be worn.
- e. All clubs should ensure that players' nails are cut short and smooth, so that no time is lost when umpires check nails.
- f. For U12 and U13 matches it is imperative that teams keep to time and do not leave the court at the intervals. Drinks should be placed neatly together at one end of the court without causing an obstruction for the umpire.
- g. Anyone wishing to take photographs must register his/her name and address at the official table. An '*Authorised Photographer*' stick-on label will be supplied at U12 and U13 competitions. It is the responsibility of U14 and U16 team managers to monitor anyone taking photographs during their matches. Any person violating this rule and found to be photographing will be asked to leave. Please advise all parents and supporters to avoid any embarrassment to them and the officials.
